Firefighters' Pension Scheme (Northern Ireland) 2007 *New Firefighters' Pension Scheme (Northern Ireland) 2007*

Additional Pension Benefit Factors

The purpose of this note is to provide revised tables of factors for the calculation of additional pension benefits in the Firefighters' Pension Schemes in Northern Ireland, required under the following rules of the Firefighters' Pension Scheme (FPS) and The New Firefighters' Pension Scheme (NFPS):

- > Article B16C of FPS (Northern Ireland) Order 2007 (SI 2007 No. 144),
- > Article 17B of NFPS (Northern Ireland) Order 2007 (SI 2007 No. 215)

The factors have been revised in light of information emerging from the actuarial valuation currently in progress. The revised factors are set out in the attached Annex.

The revised factors are effective from 1 July 2014, including for converting all relevant payments for the year to 30 June 2014 to additional pension benefit, and for calculation of all future additional pension benefits under the Rules above, until such time as a further review of the factors occurs. The factors replace those in the GAD guidance "Continual Professional Development (CPD), Pension Factors" dated 27 June 2012.

The revised factors are in the same format as those in the GAD guidance dated 27 June 2012 and should be used in the same way as set out in that guidance, except that there are now 3 sets of factors as follows:

Column (2) of the Table gives factors for the 1992 Scheme.

Column (3) of the Table gives factors for the 2007 Scheme (NOT Special members).

Column (4) of the Tables gives factors for the 2007 Scheme (Special members)
